# <u>WG1</u>

### Resolution 1082:

ISO/TC204 notes that:

- the ITS community recognizes the importance of IS14813-1 as the foundation for the creation of standards to be used within the overall ITS community;
- the only requirements that it contains are for the definition of the content of services that ITS can be called upon to provide;
- the best way to promote the use of this standard is to make it "freely available", for which there is a precedent in other parts of ISO, e.g. JTC1.

ISO/TC204 instructs its Secretary to engage ISO Central Secretariat in a dialogue to explore the possibility of making this standard freely available to the global ITS community.
